

AGREEMENT TO DENTAL TREATMENT

This Agreement to Dental Treatment ("Agreement") is entered into between [Simpladent Clinics], located at [Radisson Blue, Kaushambi, Delhi NCR], herein referred to as the "Clinic," and the patient, herein referred to as the "Patient," who is seeking dental treatment at the Clinic.

1. Nature of Agreement

1.1. The Patient hereby acknowledges and agrees that they are seeking dental treatment services at the Clinic, which may include but is not limited to dental implants, oral surgeries, and related dental procedures.

1.2. The Clinic agrees to provide dental treatment services to the Patient, subject to the terms and conditions outlined in this Agreement.

2. Scope of Treatment

2.1. The specific dental treatment to be provided will be determined by the Clinic's dental professionals after a thorough examination and consultation with the Patient.

2.2. The Patient understands that treatment plans may be adjusted based on their dental health, and any additional procedures or changes to the treatment plan will be discussed and agreed upon by both parties.

3. Risks and Benefits

3.1. The Patient acknowledges that they have been informed of the potential risks, benefits, and alternatives associated with the proposed dental treatment.

3.2. The Clinic has explained the potential outcomes of the treatment, and the Patient accepts that results may vary from individual to individual.
